



Premium limits increasing!

Good news! We are increasing our premium limits for the first policy year only on new sales for select products. Premium limits for Eclipse NY, Eclipse Protector II Indexed Universal Life (IUL), Eclipse Survivor II IUL and Variable Universal Life (VUL) Survivor products sold with the No Lapse Guarantee Agreement (NLGA) will increase to the greater of 5x target and \$5mm (the current limit is \$1 million). Illustrations were updated as of September 1, 2023 with this change. These limits may change over time.
